
The Damage of the Antamina Mine

Environmental and Human Rights Violations

The Antamina Mine, jointly owned by Teck Resources, a Canadian corporation, discharges minerals (silver, copper, zinc, molybdenum, and lead) extracted from its operations located in the Andes Mountain Range into the sea of Puerto Punta de Lobitos. Since approved by the General **Directorate of Captaincies and the Coast** Guard in 1999, the dumping of mineral extracts has led to the decrease of wildlife in the bay, causing the people of the town to lose their jobs and main means of survival. What used to be a populated and flourishing city since pre-Inca times, the town is now riddled with plastic bags and bottles, tires, remains of dead animals, and stagnant pink foaming waters. One can also find thousands of human remains from ancient tombs due to the lack of protection against maintaining the final resting places of ancient communities. For those in the modern days, houses are made of cans, wood, cardboard, and whatever resources could be found in the surrounding area. The residents of Puerto Punta de Lobitos endure skin and respiratory ailments as a result of the destitution caused by the mass pollution Antamina discards as well as the lack of healthcare provided to those living in Puerto Punta de Lobitos. **Instead of financing projects to clean up the** town or provide resources to make up for the contamination, or restoring the living conditions of the people who once lived through communal fishing, Antamina financed a festival with cumbia concerts and motocross competitions despite accumulating approximately \$2.2 million in copper production in 2020.

The People V Hudbay Minerals

CASE 1: CAAL V HUDBAY MINERALS INC. AND HMI NICKEL INC

Fact: In a complaint filed in Canada in March 2011 against Hudbay Minerals (headquarter in Toronto, Canada), 11 Mayan Q'eqchi women from Guatemala claimed the company was engaged in gang rapes committed by its private security guards on the Fenix nickel mining operation in El Estor, Guatemala.

<u>Truth:</u> Hudbay Minerals permitted the rape of 11 Mayan Q'eqchi women by security personnel. They are put in a dangerous situation as they are subjected to the tyrannical power of Hudbay.



CASE 2: GERMAN CHUB V HUDBAY MINERALS

<u>Fact</u>: A victim of a shooting at the Fenix project filed a lawsuit against Hudbay Minerals on December 10, 2011. The complainant, who suffered a paraplegic injury as a result, claims that the security head for Hudbay's Fenix project attacked him in September 2009 and shot him at close range.

<u>Truth</u>: As Hudbay Minerals continue to mine on indigenous land, indigenous peoples suffer the fatal consequences of mining. They attempt to silence their voice in exchange for profit.

FRUTA DEL NORTE MINE



The Fruta del Norte mine owned 100% by <u>LundIn Gold Inc (Canadian and Swiss Company)</u> is an open-pit copper mine that is located within a 150 km long copper-gold sub-province in the Cordillera del Condor region in south eastern Ecuador. The mine averages 340,000 ounces of gold per year off the backs of local workers and on the religious land of the Shuar people.

EL ABRA MINE

Owned by Freeport McMoRan

Copper & Gold Inc. of Phoenix, El Abra ois an open-pit copper mining complex is located 47 miles north of Calama in Chile's El Loa province, Region II. 51% of the mine is owned FCX: 49% by the Corporación Nacional del Cobre de Chile (CODELCO). The El Abra operation includes a solution extraction/electrowinning facility with a capacity of 500 million pounds of copper cathode per year, a 125,000 metric ton-per-day crushed leach circuit and a similarsized run-of-mine leaching


"Extractive operations seek into our bodies and we become that mechanism of extraction and we start to extract from one another and not with apology but with license"
